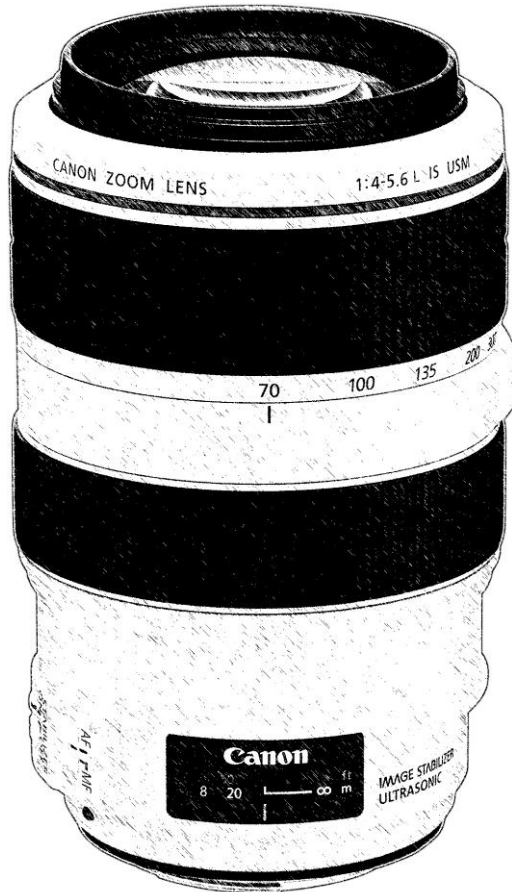

TERMS AND CONDITIONS

Entered into on _____

between

Avantech Limited (C9357), of 'Avantech Buildings', St. Julian's Road, San Ġwann, Malta, of the first part, hereinafter referred to as the "Lessor",

And

_____, of the second part, hereinafter referred to as the "Lessee";

Whereby it is mutually agreed as follows:

The Lessor hereby agrees to rent out to the Hirer who accepts to take on hire the camera lens of the make _____ (hereinafter referred to as "the Item") for the period commencing on the _____ and ending on the _____ for the consideration of _____ Euros (€ _____), which price is inclusive of Value Added Tax ("the Amount").

Calculation of Hire Period

In consideration of the above, hire periods shall be deemed to commence from the time of collection of the hired Item and to expire at the time of return. The Item shall be collected on the day of commencement of deemed hire between 8:00 and 16:30. Item/s shall be returned on the last day of deemed hire prior to 16:30.

Extension of Hire Period

3. The hirer may extend the rental period if he/she wishes upon prior confirmation of availability by the Lessor. Hire rates shall be charged according to the published rates at the time of contract. Should the lessee wish to extend from a 3 day rental to a one week rental, the client is responsible for paying solely the difference between the two package rates. This is also valid in the case of extensions from other packages; for example, extending a one week rental to a two week rental and so on.

Rental Procedure

4.1 Bookings may be made up to four months ahead of the requested hire period, and must be in possession of a valid Maltese ID card or passport during the rental period.

4.2 Bookings made by telephone shall be deemed to be provisional and shall only be confirmed upon payment of deposit in person or through electronic means.

4.3 First time lessees shall require approval by our accounts department prior to the confirmation of their order. The Lessor undertakes to ensure that all Items are thoroughly checked and serviced prior to collection. Avantech Ltd reserves the right to refuse to hire any equipment to anyone who does not meet our required criteria.

4.4 Lessees are to be charged a €200.00 safety deposit on their credit/debit card, or in cash, which is fully refunded on safe return of the lens.

Returns

5. The lessee undertakes to return the Item on the last day of the rental period prior to 16:30. Late returns shall be charged at the rate of 50% of the weekly rate per day published at the time of contract. In the event that the Hirer decides to return the Item prior to the termination of the hire period agreed upon he/she shall not be eligible to any form of refund or reduction to the amount due and mutually agreed upon and the Lessee shall accordingly have no claim whatsoever against the Lessor in this regard.

Damage/Loss Charges

6. In any case of damage to the hired Item or any related accessories, the Lessee shall immediately contact the Lessor. It is expressly agreed that the Lessee shall be wholly responsible for any damages or loss caused to the hired Item and associated accessories. Such damages include the cost of repairs, if possible, or replacement of the damaged Item/s. The decision to repair or replace rests solely with Avantech Ltd.

Optional Damage Waiver Policy

7.1 The Lessee may opt for an optional damage waiver policy covering the hired Item/s for the hired period agreed above. Such policy shall cover damages caused to the Item/s whilst in the Lessee’s possession. Such insurance coverage shall extend to any territory in which the Item/s is used, subject to prior approval by the Lessor as part of this contract. The Lessee is not covered in case of unattended property, Nuclear Risks, Sonic Bangs, War, Confiscation, Terrorism and other Cyber risks, Willful Acts and Consequential losses.

Try before You Buy

8.1 Should the Lessee decide to buy the same lens model from the Lessor within 30 days of the rental period’s end date, the Lessee is refunded 50% of the hire charge, which is deducted from the selling price of the new lens.
